Animal Specific Rules (Please see Livestock General Rules for additional Livestock Barn Rules and Regulations)

1. Exhibitor may show three (3) market hogs, but only two (2) will be allowed to show per class.
2. Weigh in will be 12:00 noon, Wednesday, September 5, 2018 to establish classes. This will be the only weigh-in time.
3. The top 25% market hogs (up to 10), as determined by the judge, will be eligible for the Junior Premium Auction. County Bred, Commercial Gilt, and Heavyweight Divisions are not eligible for the Auction.
4. Classes for the Market Hog Show will be determined prior to judging.
5. The Junior Premium Auction will be held Friday, September 7, 2018 @ 6:30 pm.

Health Requirements (All swine must meet the following health requirements. If swine do not meet these health requirements they will not be allowed to enter the fairgrounds.)

1. All animals are subject to inspection by fair officials, veterinarians, and state-federal personnel.
2. No animal showing symptoms of disease will be allowed to enter the fairgrounds.
3. All swine will be required to have an official USDA tag (840) or Premise ID tag.
4. Swine must be accompanied by a Certificate of Veterinary Inspection issued within 90 days prior to the exhibition.
5. All swine to be tested negative from Brucellosis within 90 days of exhibition or originate directly out of a Validated Herd with Validation number and date of last herd test shown on certificate (barrows exempt from Brucellosis testing, but must be Pseudorabies tested).
6. Animals to be tested negative for Pseudorabies regardless of age within 90 days of the exhibition on a test approved by the state veterinarian or originate directly out of a Qualified Pseudorabies Free Herd, with Qualified Herd number and date of last test shown on certificate.
7. Free of other contagious, infectious and communicable diseases (erysipelas, atrophic rhinitis, etc.).

Showmanship Information

1. Showmanship Showdown - Saturday, September 8, 2018 @ 6:00 pm.
2. Showmanship must be registered for separately online in addition to registering your animal.
3. Animals used to compete in the Showmanship Showdown must owned by the Exhibitor and be an animal the Exhibitor has shown previously in the week.
